Net Weight of Gloves: Per 1 piece

- Small: ≥3.3g +/- 0.2g - Medium: ≥3.5g +/- 0.2g - Large: ≥3.7g +/- 0.2g - X-Large: ≥3.9g +/- 0.2g

Box Dimensions: 220mm x 120mm x 60mm

Quantity of Gloves per Box (all sizes): 100 gloves/box

Box Gross Weight (Based on gloves size):
