**THIS BAIT STATION IS NOT TAMPER-RESISTANT. USE INDOORS ONLY IN AREAS INACCESSIBLE TO CHILDREN AND PETS.**

**FIRST AID: IF SWALLOWED:** Call a poison control centre or doctor immediately for treatment advice. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call poison control centre or doctor for treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

For all cases of human ingestion, immediately notify a physician or poison control centre. If pet or livestock poisoning is suspected, immediately contact a veterinarian. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN, PETS AND LIVESTOCK.** May be harmful or fatal if swallowed or absorbed through the skin. Rubber gloves must be worn when handling product and when disposing of dead rodents, unconsumed bait and empty containers. Avoid contact with eyes, skin or clothing. Wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Wash skin thoroughly with soap and water after handling. Wash contaminated clothing, separately from other laundry, with soap and hot water before reuse. **KEEP AWAY FROM FEED AND FOODSTUFFS.** Keep out of lakes, streams or ponds.

**TOXICOLOGICAL INFORMATION:** This product contains petroleum distillates. Vomiting may cause aspiration pneumonia. If swallowed by humans, pets, wildlife or domestic animals, this material may reduce the clotting ability of the blood and cause bleeding. Vitamin K1 in the form of intramuscular or subcutaneous injections, or by oral ingestion are suggested remedial treatments for anticoagulant poisoning. The severity of the case measured by establishing prolonged prothrombin times (P.T.) will determine appropriate therapy. Monitoring P.T. will indicate the necessity of repeated treatments.

**DIRECTIONS:** Place the Ramik<sup>®</sup> Mouse Maze<sup>™</sup> indoors in locations where mice are most likely to find and consume the bait. Place the bait in concealed corners, along walls, where mice feed. Place at 1.5 to 3m intervals where mice are active. Maintain an uninterrupted supply for a period of 15 days or more.

**USE LIMITATIONS:** DO NOT place bait in areas where there is a possibility of contaminating food or surfaces that come in contact with food. **DO NOT USE THIS PRODUCT OUTDOORS OR IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS, OR NON-TARGET WILDLIFE.**

**STORAGE:** Store in a cool, dry place away from other chemicals and food or feed. Store products not in use, in original container, in a secure location inaccessible to children and non-target animals.

**DISPOSAL:** Wrap used or damaged bait stations and discard in household garbage. **DO NOT** use damaged bait stations. Dispose of unused bait in accordance with local requirements.

**RODENT DISPOSAL:** Dispose of dead rodents in garbage or by burying.
